<b>On-Call Pregnancy Case Management</b> Need to speak with our staff outside of the weekly updates? Need someone to attend local appointments? We're available!	\$50/hr billed in 30 min increments
<b>California Escrow Management</b> Due to California law, all escrow accounts managed by California companies must first be reviewed and approved by 3SS. This fee covers the agency side of the process and will be in addition to the escrow company's fee. Due with 2 <sup>nd</sup> Installment.	\$500

I (we) understand that the deposit for the Agency Fee is nonrefundable, but that we are able to utilize it for a different carrier if (1) the gestational surrogacy candidate does not pass screening, or (2) the candidate is unable to proceed or declines to continue prior to contract phase. I (we) acknowledge that all fees must be paid prior to embryo transfer or the procedure may be postponed.
